#### 3. RESULTS AND DISCUSSION

## Counseling

## **Technical training**

In addition to the presentation of material provided by Prima Indonesia University Lecturers in the implementation of PKM at Khairul Imam IT High School, they also conducted technical training, namely training in preparing financial reports using technology and using the DJP online application in preparing annual tax reports conducted by teachers in the Khairul Imam IT High School environment. The training uses a computer/laptop device and uses a projector in the presentation of material and technical steps.

#### **Training Implementation**

In this activity, all participants began the process of preparing financial reports using the Excel application as well as reports stored in Google Drive so that reports can be seen by anyone who has the right to see the report. Furthermore, teachers are also given training in preparing annual tax reports / SPT online using the DJP online application, in this training the teachers are asked to create an online DJP account and then fill in a dummy SPT report using the application.

# **Implementation of Mentoring**

The results of evaluation and mentoring show that the service can have an impact on the results of teacher motivation, which is seen to be starting to be proficient in the use of technology in preparing reports and starting to recognize the preparation of tax reports online so that teachers can be more efficient in time management.
